## Training provider guidance to EPA

Before **enrolling apprentices** on your programmes its **important** that you **understand** the **assessment plan** to ensure that you can **meet its requirements as a training provider.** 

### What is an assessment plan?

An assessment plan is a **structured document** that outlines the **assessment methods** and **criteria** used to **evaluate** an apprentice's **knowledge**, **skills**, and **behaviours** against the requirements of a **specific apprenticeship standard**.

It serves as a **roadmap** for both the **training provider** and the **employer**, detailing how the **apprentice's competence** will be **assessed** throughout their apprenticeship programme.





# Key components of an assessment plan

## Overview of the apprenticeship standard:

The assessment plan begins with an overview of the apprenticeship standard, including its **title**, **level**, **duration**, **and occupational profile**. This section provides context for the assessment methods and criteria outlined in the plan.

Please make sure that your learners **job description matches up with the occupational profile.** If there are gaps, these need to be addressed with the employer before the programme starts.

### **Assessment Methods:**

The plan also **specifies the assessment methods** that will be used to **evaluate** the **apprentice's competence.** This may include practical assessments, written exams, professional discussions, observations in the workplace, and portfolio reviews. Each assessment method is described in detail, including its **purpose, format, and duration.** 

Best practise would be to incorporate these methods into your evidence collection techniques so that your apprentices are familiar with the way they will be end point assessed.



# Key components continued...

#### **Assessment Criteria:**

For each assessment method, the plan outlines the specific criteria against which the apprentice will be assessed. These criteria are derived directly from the apprenticeship standard and reflect the knowledge, skills, and behaviours that the apprentice is expected to demonstrate.

Please make sure that your learners can achieve the assessment criteria in their job role. Also ensure that where the assessment criteria 'drift' from the wording of the KSB's you have identified these, and all apprentices are aware of what will be required of them during their assessment.

## **Grading Criteria:**

In some cases, the assessment plan may include grading criteria to differentiate between levels of performance. This allows assessors to assign grades or ratings to apprentices based on their performance against the assessment criteria.

Be aware of what is expected at the different levels and how your apprentices can achieve higher grading outcomes.



# Key components continued...

#### **Assessment Schedule:**

The plan may include an assessment schedule, detailing when each assessment will take place throughout the apprenticeship programme. This helps ensure that assessments are conducted in a timely manner and that apprentices have sufficient time to prepare.

Before **Gateway** make sure you hold **EPA preparation sessions** and help apprentices to be at their best on the day.

#### Roles & Resonsibilities:

The plan clarifies the roles and responsibilities of key stakeholders involved in the assessment process, including the training provider, employer, assessors, and apprentices themselves.

This ensures that everyone understands their role in supporting the apprentice's assessment journey.

### **Quality Assurance Procedures:**

Finally, the plan will **outline quality assurance procedures** to ensure that assessments are **fair, consistent, and valid.** This may include processes for **standardisation**, **moderation**, **and validation of assessment outcomes**.

### **Further Information:**

The assessment plan is a **vital tool** for ensuring the **effective assessment of apprenticeships** in providing **clarity and structure** to the assessment process, and helping to ensure that **apprentices** can **demonstrate their competence** against the requirements of their chosen occupation.
